## **Request of the expression of interest for Individual Consultancy services**

Date: May 28, 2019

The TB Europe Coalition (“TBEC”), non-profit foundation registered in the Netherlands, announced call for expression of interest **to develop regional briefing package on budget advocacy for EECA countries** in the framework of the implementation of the current tasks of the Global Fund Multi-Country Program “Advancing People-Centered Quality TB Care – From the New Model of Care Towards Improving DR-TB Early Detection and Treatment Outcomes” (TB-REP 2.0).

### **Scope of services:**

- Describe the role of civil society in budget advocacy.
- Identify opportunities and challenges for civil society in budget advocacy, including participation in social contracting mechanisms;
- Provide examples of successful budget advocacy from EECA;
- Provide examples of budget advocacy that let to sustainability of services in the context of transition from international funding of TB care to national.

### **Duration of Services:**

- The services are expected to be performed till December 31, 2019, with the possibility of continuation for the next TB-REP2.0 implementation periods.

### **Conditions:**

1. You are invited to submit your expression of interest for the consultancy services mentioned above.
2. TBEC offers the following type of cooperation:
  - Consultancy Agreement with an Individual Consultant/Expert
3. The contract will be awarded on the competitive basis to Consultant/Expert with the highest qualifications and that meet all requirements described on Terms of References (ToR<sup>1</sup>). Consultant will be evaluated based on the qualifications, consultancy fee will be negotiated based on the consultant’s expertize evaluation results.
4. Your expression of interest should contain the following documents that must describe you experience and qualification according to requirements described on ToR.
  - CV
  - Covering letter
  - Letters of recommendation will be considered an asset

7. The evaluation and selection will be conducted through procurement procedures set out in the TB-REP2.0 sub-grant agreement between TBEC and PAS Center, as a TB-REP2.0 Principle Recipient of the Global Fund to Fight AIDS, Tuberculosis and Malaria and are aligned to the World Bank Guidelines.
